Information

- * A. Hoffman announced the new procedure AP 5031 Instructional Materials Fees, the new procedure AP 5104 Contract Education and the AP 5152.1 Military Education deactivation are on the Mesa Academic Senate's November 30, 2020 meeting agenda. A. Hoffman reported to the Mesa Academic Senate several CRC members did not support the new AP 5104 Contract Education. To provide additional information/discussion on the AP 2104 Contract Education several guests have been invited to the Mesa Academic Senate meeting.
- * A. Hoffman updated the committee on Miramar's request for Asian American Studies (ASIA) designator. This continues to be discussed by all three college's discipline faculty and more information will be provided at the December 3, 2020 CRC meeting.
- * J. Parker informed the committee currently there are 20 Mesa courses being inputted into CurricUNET to request CSU Area F Ethnic Studies articulation. It is anticipated the following courses will be on the December 3, 2020 CRC agenda: BLAS 100, BLAS 104, BLAS 116, BLAS 120, BLAS 130, BLAS 140A, BLAS 140B, BLAS 150, BLAS 155, BLAS 165, BLAS 175, CHIC 110A, CHIC 110B, CHIC 135, CHIC 141A, CHIC 141B, CHIC 170, CHIC 190, CHIC 210, CHIC 230.
- * C. Lopez explained the Mesa College Ethnic Studies Task Force goal is to advance and meet the needs of the local community's ethnicities. Mesa has two well established ethnic studies departments (Black Studies and Chicano/a Studies) and at the [Fall 2020 ASCCC Plenary](#) two Task Force resolutions on Ethnic Studies were presented and approved. C. Lopez reiterated J. Parker's list of courses that will be submitted for CSU Area F Studies articulation and noted the challenge of faculty being able to create CurricUNET proposals outside of their discipline. (This challenge will be looked into by A. Hoffman.) The exploration of Mesa providing new ethnic studies courses/ departments is on track and Chancellor Carrol's 11/18/2020 memo supports the Task Force's actions. (Note: C. Lopez's report handout and Chancellor Carrol's memo will be emailed to CRC members.)
