- * MSC M. Cox/L. Hensley to approve the February 18, 2021 agenda.
- * MSC N.S. Robinson/M. Cox to approve the February 4, 2021 minutes with the adjustment of A. Moctezuma being present for the meeting.

Information

- * A. Hoffman commented D. Short's [Competency-Based Education \(CBE\)](#) presentation was emailed to members as a hyperlink. Mesa's Computer Information (CISC) department will be applying for Mesa to be a part of the State Chancellor's CBE pilot program. The deadline to apply is March 5, 2021.
- * A. Hoffman informed the committee District and the AFT have come to an agreement on AP 5104 Contract Education. After the revised AP 5104 was reviewed and discussed the following motion was made and passed.
- * MSC N.S. Robinson/E. Helscher to support the AP 5104 revision and forward it to the Mesa Academic Senate.
- * A. Hoffman reported Miramar is requesting two more new course designators: Service Learning/SERV and Audio Production and Engineer/AUDI.
- * MSC M. Cox/N.S. Robinson to support Service Learning/SERV and hold support for the Audio Production and Engineer/AUDI) for further discussion by City, Mesa and Miramar Music departments.
- * A. Hoffman conveyed the news of a name change for San Diego Continuing Education. It has been changed to [San Diego College of Continuing Education](#). Two hyperlinks are provided at the end of these minutes for more information on this change.
- * A. MacNeill, as proxy for I. O'Connor, reported on the Chancellor's Office Executive Orders: Excused Withdrawal (EW) & Pass/No Pass (P/NP). A. MacNeill explained the Excused Withdrawal has two components: EW Extraordinary Conditions and EW Extenuating Circumstances. The EW Extraordinary Conditions is new for such situations as COVID-19, floods, fires, etc. and does not have a sunset date. It will be placed into Title 5 and there is no limit on the number of times it can be utilized by a student. The EW Extenuating Circumstances is for accidents, injuries, etc. and can be utilized by students one additional time after three uses. A. MacNeill had no update information on the Pass/No Pass (P/NP) so I. O'Connor will need to provide an update at a later time.
- * A. MacNeill informed the committee to contact I. O'Connor to register for the [2021 Curriculum Institute](#) which will be held virtually July 7-9, 2021.

Status of Mesa ADT Degrees

- * The Music AA-T Degree revision was BOT approved and has been submitted to the State Inventory (COCI).
- * The Chemistry AS-T continues to await more information from state officials before it can be resubmitted.
- * A. Svedberg informed the committee N. Griffin is now the state official reviewing Mesa's ADT degrees.
