- \* The PCAH Substantive/Non-substantive Program Resolution was approved by Mesa's Academic Senate and has been submitted to the ASCCC [Spring Plenary](#) for debate as S21 Reinstatement of Non-substantive Revision Category for the Program and Course Approval Handbook.
- \* The draft 2021-2022 CRC Calendar of meetings was discussed and will be voted on at the May 6, 2021 CRC meeting.
- \* A. Hoffman requested faculty committee members to email A. Hoffman/A. Svedberg as to whether or not they plan to continue to be on the committee in the fall. A. Hoffman stressed it is important to know in order to have a full contingency of members.
- \* The AB 928 Fact Sheet for ADTs handout was discussed with I. O'Connor reporting the AB 928 Fact Sheet outlines 3 main areas of change. First, establish an intersegmental committee to increase communication, TMC review, and address the creation of STEM ADTs. Second, consolidate all the General Education into one singular pathway. And third automate the ADT pathway so students are automatically enrolled in an ADT pathway as they enter the college and have an opt out option. The Assembly Higher Education Committee will be meeting on April 22, 2021 to discuss the changes.

**Status of Mesa ADT Degrees**

- \* The Music AA-T Degree has been reviewed at the State Inventory (COCI) level and the reviewer has requested revisions. The revisions are being worked on and the degree will be resubmitted after all of the revisions have been completed.
- \* The Chemistry AS-T continues to await more information from state officials before it can be resubmitted.
