Resolution 18.4.2 – Resolution for Increasing Number of Contract Faculty: (Perigo)

Whereas, AB 1725 states: "...at least 75 percent of the hours of credit instruction in the California Community Colleges, as a system, should be taught by full-time instructors [contract faculty]," recognizing that student success is highly dependent on having more opportunity for contact, mentoring and engagement when they have access to faculty outside of the classroom and during office hours;

Whereas, the success of students is highly dependent on having sufficient faculty to participate not only in student learning and assessment but also outside of the classroom in governance and governance assessment, accreditation, institutional planning, resource development and allocation, development and maintenance of curriculum, equipment and facilities, advisory processes and other community and industry partnerships, grants and other state sponsored efforts, and processes for matriculation and articulation between our academic sector partners, as reflected in ACCJC eligibility requirements 14, 15 and 17 and most of the Accreditation Standards;

Whereas, increased accountability by the state and accreditation bodies has exponentially increased the workload of departments;

Resolved, that the Academic Senate of Mesa College urge the continued funding of full-time faculty positions.

Whereas, the principle of participatory governance in the California Community Colleges has been established in practice and codified in law (AB 1725);

Whereas, participatory governance only functions when it is acknowledged by all levels of administration and faculty governing bodies;

Whereas, confidence in the leadership of the chief executive of a campus or a system is integral to the effectiveness execution of the California Community College mission;

Whereas, the faculty of Mesa College have become so concerned about the circumstances at the state including but not limited to the lack of access to the State Chancellor and lack of access to important conversations that can have dramatic impact on our system such as performance-based funding and the fully on-line community college,

Whereas, the Chancellor has demonstrated a lack of transparency, a lack of collegial consultation, has actively blocked faculty leaderships access to meetings in which decisions will be made, and a lack of acknowledgement of the concerns of the faculty;

Resolved: The San Diego Mesa College faculty affirms a vote of no confidence for California Community College Chancellor, Eloy Oakley.



 - a. The Task Force added Student Mental Health Services to the plan as suggested by Senator Helen Greenbergs.
 - b. The Task Force also incorporated the suggested changes from the approximately 15 feedbacks submitted.
- 2. Howard Eskew reported the Task Force also worked on answering the "Optional Question".
- 3. Manuel Velez reported Faculty asked for as much "blue" area on the Gantt chart as possible.
 - a. Color Codes:
 - **Blue** (Inquiry)
 - **Green** (Design)
 - Orange (Implementation)
 - b. Dina Miyoshi said element #9 should not be all **orange**.
- 4. John Crocitti said Enrollment Management can help with element #9 (Proactive and Integrated Student Supports)
- 5. Jonathan McLeod said the Steering Committee needs to codify that "Shared Governance" is part of Guided Pathways to ensure that everyone will have a seat at the decision-making table.
- Manuel Velez said the Steering Committee will coordinate and implement the GP Work Plan activities.
