XI. Round Table: Phone Recordings During SDMC AS Meetings – Impact on Civility & Collegiality

A. The following members provided comments.

1. President Andrew Hoffman:

As reported by Andrew Hoffman:

"Recently, there have been times when people, including members of the Senate, have recorded the proceedings of the Senate using a cell phone. While the Senate meetings are open to the public and subject to the Brown Act – making these actions legal – this has a chilling effect on the proceedings. Still, the district lawyer, Ljubisa Kostic, has confirmed that these recordings are legal. There is no presumption of privacy at a public meeting."

However, what is legal is not necessarily collegial. This can create an atmosphere of hostility, and many people not to want to speak when being recorded. Also, recordings may be published online in social media, which may create threats to people, even if unintended by those doing the recording. Therefore, recording individuals at a Senate meeting can be very intimidating.

We could record all our meetings as a matter of routine and find a way to publish them (perhaps on YouTube, such as the district Board of Trustee meetings are). However, this does not stop people from making their own recordings.

Please keep in mind that we are all colleagues; many of us have worked with those recording the meetings for years. We need to encourage more collegial approaches to handling disagreements."

As reported by John Crocitti:

- "Context is critical in the debate over recording.
- I am lukewarm about Ryan's and Mary's thoughts to record every meeting. However, this will not prevent individuals from recording on their own.
- I agree that in my more than a decade on the Senate, no one video recorded until last fall and this spring.
- Context: One of the people who video-recorded last fall also posted names of faculty on Twitter two years ago, putting those faculty at risk since it is easy to know where they work and live.
- Context: That same person posted things about me on her personal Facebook page, which could put my life at risk.
- The important point is that one of the people recording us has a history of posting things about us on social media, which poses a risk to our safety."

5. Mary Gwin:

As reported by Mary Gwin:

"If we choose to record every meeting, we can host the videos on YouTube, like the District does. However, I am not in favor of recording every meeting because it won't automatically stop someone from recording. The fact is that recording a Brown Act meeting is legal. It does not seem to me to be in the spirit of working together to participate in governance. I have tried to understand why someone would feel the need to record, and it seems to me that people record others when they fear that they are going to be treated unjustly. I think we should pay attention to that as well."

6. Cathy James:

As reported by Cathy James:

"In general, I stated that although this was my first year as a member of Mesa's Academic Senate, that I was a former member of both the Miramar Community College and Cal State San Marcos' Academic Senates. Both campuses audiotaped meetings for the convenience of the secretary to ensure accuracy for the meetings. They always announced to the group the date and that we were being recorded. They would occasionally turn off the recorder if something was not meant to be on the record.

That is why I expressed my surprise that at a prior meeting that at least one person was using their phone to videotape everyone during a very crowded and controversial meeting. I assumed that individuals were always supposed to announce to their colleagues that they were being recorded, and what their intentions were for broadcasting it (e.g. public or private viewing). I discovered that according to the Brown Act that we could not prohibit the filming or broadcasting of public meetings, like we could in our classrooms.

Consequently, I agreed with the prior speakers who felt that the sudden filming of a particular meeting seemed to stifle free speech. Moreover, I wanted my colleagues to be mindful of what they post on social media if it has the potential to cause

physical or other harm to others. When I was at Miramar College, the Promise Keepers offered money (up to \$100) to students and others to film and post video of "liberal professors" who were forcing their views on "innocent students." At CSUSM, my students were concerned if I was the "African American female professor" (they claimed that more derogatory words were used) who was being harassed by Tom Metzger's followers. It wasn't me. It was one of the three fulltime Black women professors. Her lectures criticizing or exposing "White male privilege" were among the things they did not like about her. The professor had to be escorted by security to and from her classroom. She also, had a peephole drilled into her office door to ensure her safety

I was disappointed that my students and not my chairperson were the ones to inform me about the harassed professor. When I asked my chair about the situation, she informed me that it wasn't me who was receiving death threats, so there was no need to worry! Well, I felt otherwise. Therefore, just because it may be legal to film and post our meetings on social media, one should be mindful of the potential for harm, especially those of us from marginalized and vulnerable groups."

"I'd like to note that as a new senator this semester, these conversations about collegiality and recording for nontransparent reasons also have ramifications for future senators. Colleagues who may be interested in joining Academic Senate will understandably have concerns about their own safety and standing on campus. If we would like Academic Senate to be a space where prospective senators feel welcome and excited to participate, I encourage us to act in ways that demonstrate goodwill."

As reported by Alison Primoza:

"I commented that it seemed that senators were in agreement that it was not collegial for senators nor visitors to the senate, to record video or audio of our meetings. That it is intimidating and has a negative effect on senators and others' willingness to speak and therefore limits free speech and causes harm to those who are recorded . I asked the question, since the Brown Act allows this, what can we do as a body to prevent further harm to the Senate? Several senators expressed that discussing the problem openly, like we did today (April 8, 2024) would be itself a deterrent."
