"The elections committee sent ballots out for the officer elections. We expect a delay on a final count as the representative at District had a personal issue that has him out of the office for an unknown number of days. The committee will reveal the results of the election as soon as we hear, though we note that the election is uncontested. The committee also noted that we called for and received nominations for the five adjunct representative positions. Five nominations were received. The names and statements were sent to District for the creation of ballots. The ballots are expected to be sent out as soon as the District contact returns."

"Two new committees are available for faculty to join. The first is ALMA, which stands for the Alliance for Latine Mesa Achievement. This committee was approved by the President's Cabinet last fall and is co-chaired by Toni Parsons. The committee is seeking faculty representation from diverse disciplines. The second committee is the New Faculty Institute (NFI) Advisory Committee. Blythe Barton is seeking input and ideas from faculty for NFI. This group might be an ideal committee for faculty who have recently graduated from NFI to share their ideas on things missing from the program, or if you would like to highlight the content that was really valued. More experienced faculty, who did not have the opportunity to attend NFI may also be ideal members, as they have a different perspective."

h. President: Andrew Hoffman

As reported by Andrew Hoffman:

"The ACCJC Task Force met this morning. We talked about a number of important issues. First, while we recognize that mid-semester is not the time when a lot of outcomes are being recorded, we're very aware that we have a long way to go to be in compliance – 75%. So, I warn to remind everyone who is planning to submit outcomes data at the end of the semester: Summer is Coming. We urge department chairs, DOCs, and faculty to get the data on outcomes submitted before leaving Mesa for the semester. Each department can and should come up with its own schedule, but the work needs to be done by June 30. Realistically, you might want to have this done earlier in June. Discuss that with your department.

As for the closing the loop activities, departments should plan to devote time during the August flex days. To follow up on an item raised in the last Senate meeting: COA is working on finalizing language regarding programs that are non-compliant with the Outcomes effort. The goal, of course, is that no program is non-compliant as that puts the college at risk. While in the most extreme event the program could be excluded from applying for new resources, the main focus is to reach out to those that need help so that does not happen in the first place. This is going from COA to PIE, and then to PCab.

COA is also working on the first draft of the report that eventually will be submitted to ACCJC in the fall. The workgroup includes Hai Hong, Eliza Rabinovich, Dina Miyoshi, Amanda Johnston, and myself.

Speaking of courses, Common Course Numbering is entering its third phase. Subject areas include History, English, Child Development, Communications Studies, Biology, Political Science, ESL, Art History, Chicano/a Studies, Music, Kinesiology, Math, Accounting, Sociology, Business, Psychology, amongst others. (Check your email for an email from ASCCC on March 4 and Sue forwarded it as well on March 5.) Nominations are Due April 15.

FHP list has gone to PCab where it had its first reading. The second read and vote will happen at PCab's next meeting.

I want to follow up on pay for adjuncts to participate in shared governance was an item for discussion with the AS presidents and Jim Mahler, the AFT union leader. There is an annual pool of \$50,000 set aside for this (\$44,000 after initial taxes and fees). Funds are paid based on how many hours are submitted – so the more hours, the lower the hourly pay for everyone. The union has rejected the idea of splitting the money evenly amongst the colleges as it will mean different pay for the same work; I suggested a per-person cap on total hours. The Miramar College ASP prefers to have the money appropriated by committee, which I think is unworkable in practice. More on that to come.

This morning I received an email with City College's rewrite of the student evaluation form for classroom faculty. There were a number of rewritten questions, and three additional questions added."
