A. Robyn Bolden & Jordan Nash - Black Student Success Fellows Program:

As reported by Jordan Nash:

"As Black Leadership Fellows, Robyn Bolden and I (Jordan Nash) are working to establish and develop a sense of community for our Black students on campus. By introducing them to leadership opportunities, connecting them to resources and departments, and building intentional relationships, we are aiming to foster our students' success here at Mesa College. Various events have been held this semester that have allowed students to network and build connections. Our Black Student Meet and Greet, Ice Cream Social, and Black Excellence Symposium saw great success with establishing and building rapport amongst Black students and their peers. We look forward to continuing this work and creating retention so that our students have support outside of the campus and may be successful in their academic endeavors.

B. Dean Brian Weston - The CA Virtual Campus (CVC) and OEI:

- 1. Dean Brian Weston's November 9, 2022 Committee of Chairs Presentation:
 - a. Purpose:
 - Allows Students currently enrolled in a California Community College (CCC) to instantly enroll in online courses offered at eligible colleges without filling out a separate application.
 - b. Emergency Conditions Memo:
 - What is it? A memo from the CCC Chancellor's Office that tied emergency funds to a set of expectations for the colleges that accepted emergency funds.
 - Some of the expectations relate to @ONE and some of the expectations relate to the Course Exchange.
 - The CCC Chancellor's Office June 14th Memo (FS 22-07) detailed the COVID 19 Emergency Conditions Allowance eligibility requirements.
 - c. CVC Steps to Meeting the Emergency Conditions Allowance Requirements:
 - September 1, 2022: CEO/College President signs the Consortium Agreement.
 - January 1, 2023 Implementation:

 - * Which Courses are Listed?

 - g. CVC/@ONE Local POCR Reframing:
 - Goal:
 - * To quickly and significantly increase the number of fully certified Local POCR teams and aligned courses.
 - Strategy:
 - * Accelerate Local POCR team training and course review processes
 - * Move badging authority to a Local POCR team and position CVC/@ONE team as trainers and support
 - Reminder:
 - * Having a Local POCR team and process is required per the CVC Master Consortium Agreement. (But, we do not have to enforce Appendix A, Section 2b, which requires incremental benchmarks and alignment of 20% of courses/sections. Consider them aspirational goals.)
 - POCR Chaffey College Data after Implementation:

- * There was a 12% increase in online course success rates after POCR alignment
- * Success rates increased by 32% for Black Students and 24% for Students ages 25 to 29 years old.
- h. Exchange Enrollment Data: October 2020 August 2022
 - 1,043,009 Unique Course Searches
 - 23,896 Redirects to CCCApply
 - 2,411 Cross Enrollments:
 - * Nearly 20% enroll at their home college
 - * 81% cross-enroll in only one course per term
 - Top Subject Search Terms: Biology, Chemistry, Computer Information Science and Mathematics
- i. Implementation Progress:
 - 73 Home Colleges
 - 57 Live Schedule Data Colleges
 - 20 Teaching Colleges (35 Projected by year-end)
- j. Questions:
 - Will all courses have to be listed in the consortium or will the college be able to select specific ones?

V. OLD BUSINESS:

A. Californian Virtual Campus (CVC): Moreno Ikari

1. As reported by Alison Gurganus:

"I asked if all of the Mesa CVC students would be getting CSID numbers to access the Mesa instructional support services, such as library databases. I also inquired if there would be additional funding coming to support a potential enrollment bump as our prices are tied to enrollment numbers and our library budgets have not been increased in over 10 years. This would also potentially affect staffing in instructional support areas such as tutoring and library as there would be more need for staffing in the tutoring and reference areas."

2. As reported by Dina Miyoshi:

"I asked Brian Weston two questions:

The first pertained to whether decisions about whether to allow certain courses on the CVC is up to each individual college in our district or if all the colleges in our district have to align with each other. The second question pertained to whether program faculty had a say in whether to accept a course completed via the CVC as comparable to our course (i.e., follow our curriculum and petition process for accepting courses completed at other institutions)."

3. As reported by Cynthia Rico:

"If the District CVC-OEI taskforce has an opportunity to provide comments to the State Chancellors Office, there is a concern about the Online Counseling Badges. There is an understanding that the teaching college will provide counseling for students from other campuses, and this is a challenge when the teaching college is not fully trained in the students' home campus requirements. It would be best for the student be referred back to the students' home campus for counseling ensuring the student will receive the most correct information."

4. As reported by Chris Sullivan:

"I guess my biggest gripe is how this, another legislative mandate, suddenly appeared in its current form.

The original CVC bill, SB1437 (Padilla), had funding proposed for it back in 2008-2009. The funding source was, at that time, something called the California Teleconnect Fund (CTF).

The wording from the bill indicates that, among other things, the CVC is intended to "help faculty convert traditional courses into an online format." The CTF was established in 1996 "to provide a 50% discount on selected telecommunications services to schools, libraries, qualifying hospitals and health clinics, and nonprofit community-based organizations (CBOs) offering healthcare, job training, job placement, educational instruction, and community technology services."

The statewide chancellor's office (2021) optimistically offers this: "CVC helps students up level their skills, train for new careers and transfer to a four-year university. In turn, CVC helps increase completion rates across campuses and reaches new students through cross-enrollment. While CVC is predominately student-facing, there are significant benefits for colleges and system stakeholders who use the platform. Staff and faculty can leverage the system's wide reach and the capacity of their fellow colleges to assist students in their educational goals."

This cynicism underlying this optimism is revealed in the following statement: "For community colleges, online learning represents a *large fiscal advantage*. Increasing on-campus programming entails renovations to, expansion of, or construction of new facilities. From more parking lots to expanded food service options, when community colleges grow, so too does the need for campus updates. *While these capital construction projects can be incredibly expensive, expanding the online campus is not*. Additionally, offering a virtual learning experience expands the footprint of community colleges to a much larger audience. While most online students live within 100 miles of their school, that school nevertheless has the ability to enroll students throughout the country and the world – *all without having to pay for expansion of their brick-and-mortar campus.*" – Grace Chen, "California Virtual Community College System Increases Choices, Transfers." This is not about "equity" or "student success." It's probably not really even about enrollment management. It's about saving the bottom line.

Long story short: I, personally, would like to see

- 1) a no-BS powerpoint or some other presentation that tracks the evolution of this bill to its current iteration. How and when the "hold harmless" clause get mixed up in this?
- 2) the district office update its research reports and data tracking with regard to online classes"

Credit for Prior Learning (CPL) Workgroup:

CPL is continuing its work with inputting programs into the Military Articulation Platform (MAP). As an example,

Culinary Arts has most of their programs entered and the workgroup is looking into other programs to include.

Data Coaches Project Team:

Data Coaches continue with their training and are exploring how they will be most effective serving the campus

community.
