Pre Covid 19 Brown Act Teleconferencing Requirement:
 Curriculum Institute (July 2, 2022 – July 9, 2022) Academic Senate for CA Community Colleges (ASCCC)
 "Brown Act and Parliamentary Procedure" (Sarah Harris - College of the Sequoias)/(Erik Shearer - Butte College)

"Ever wonder why legislative bodies largely meet in person? Teleconferencing requires (§54953b):

- All votes by roll call
- Agendas posted at all teleconference locations
- Each teleconference location is identified in the agenda and notice of meeting
- Each teleconference location is accessible to the public
- Members of public may address the legislative body at each teleconference location"

2. Covid 19 Brown Act Teleconference Updates - AB 361:

Curriculum Institute (July 2, 2022 – July 9, 2022) Academic Senate for CA Community Colleges (ASCCC) "Brown Act and Parliamentary Procedure" (Sarah Harris - College of the Sequoias)/(Erik Shearer - Butte College)

"AB361:

- Passed in October 2021
- Continued to suspend the portions of the Brown Act that would require posting all teleconference locations and making those locations available to the public, but only when:
 - * There is a declared state of emergency under the California Emergency Services Act

AND

- Additional conditions are met, including that the legislative body has determined that as a result of the emergency meeting in person presents risks to health and safety.
- Bill contains sunset dates; EO N-1-22 extended these to March 31, 2022 for state agencies.
- Legislative bodies of a local agency are authorized through January 1, 2024"

3. Covid 19 Brown Act Teleconference Updates - AB 2449:

Hanson Bridgett Government Practice Group (September 16, 2022 Edition)

"Key Points:

- AB 2449 provides complex and restrictive alternative teleconference procedures:
- At least a quorum of the members of the legislative body must participate in person from a singular physical location identified on the agenda, which location will be open to the public and within the boundaries of the local agency;
- A member may only teleconference for publicly disclosed "just cause" or in "emergency circumstances" approved by the legislative body; and
- A member may only teleconference for a limited number of meetings.
- The new provisions are in addition to those allowed by AB 361 (so long as there is a state of emergency) and those allowed by traditional teleconferencing rules.
- The new provisions are likely so onerous that they may not be a practical alternative for most local agency officials or for agencies that would like to meet virtually as a matter of practice."

So if you want to take a sabbatical leave in Fall 2023 or Spring 2024, you need to apply in Spring 2023. Both contract and adjunct faculty are eligible after 7 consecutive years of employment."

"CRC met Thursday. CRC voted to support a new subject indicator: CYDA (Cyber Defense and Analysis) for the provisionally approved Bachelor's degree at City College.

"No new updates this week. The Program Review platform build continues and no set timelines yet. The Program Review template and questions were included in President Hand's weekly update a couple weeks ago, if you want to begin the conversations in your programs this semester to get a head start for when the Nuventive space is ready."

- The Committee for Diversity Action, Inclusion & Equity (CDAIE): Chair Judy Sundayo
 - "CDAIE met on 10-7-22, with 25 people attending.
 - This time of year, we join the campus in continuing the celebration of Latinx Heritage Month, celebrating National Disability Employment Awareness Month, National Irish American Heritage Month, National Coming Out Day on Oct. 11, and Indigenous Peoples Day on Oct. 11.
 - Mesa's SDICCCA Diversity, Equity & Inclusion Intern for the 220-23 academic year, Afrah Saleh, had her intern duties expanded to include a Counseling Internship as well.
 - Student Affairs announced that the "Restore, Reflect, Unite" workshops is taking place this week, Oct. 10th 14th.
 - CDAIE is co-sponsoring the fall 2022 Student Advocacy Fair on Wed. Oct. 12, from 10 am 2 pm in the QUAD, and we have over 15 organizations, which have confirmed attendance.
 - The Women's Alliance embarked on a field trip to SDSU's Women's Resource Center and were very impressed. Their objective would be to have a Women's Resource Center at Mesa.
 - The Women's Alliance continues discussion on the importance of having an Asian American Studies Dept. on campus.
 - The Careering While Asian Conference in September was a tremendous success, with over 70 people attending.
 - The AANAPISI (Asian American and Native American Pacific Islander-Serving Institutions) Grant Program personnel will be interviewing for the director position soon.
 - The Asian Pacific Islander American committee will be hosting a film and discussion on "The Delano Manongs" concerning the legacy of the Filipino farmworkers, on Oct. 26th.
 - International Education Week will be Nov. 14 15th. There will be a hybrid style model
 - International Education rep spoke about the many student scholarships available for students. There will continue to be discussion about the best ways to get students notified about these.
 - International Education rep announced the re-launching of Study Abroad in Art and Spanish in Winter 2023.
 - CDAIE chair met with the Office of Institutional Effectiveness and the Task Group to compile a DEIA Discussion Guide, Glossary and timeline.

As reported by Marisa Alioto:

"ACP Event:

The Mesa Pathways team participated in the Club Rush from September $20^{th} - 22^{nd}$ to meet students and introduce them to our new Academic and Career Pathways. Students shared their contact information so that they could receive more information on the ACPs as well as more upcoming events around ACPs. Student received Pathways swag, snacks, and took a turn at the prize wheel to win various Pathways prizes. Be on the lookout for more ACP events coming soon.

Special thanks to the faculty, counselors, our Pathways Fellows, and Career Ambassadors for coming out to meet with our students, provide information, to help with the giveaways and swag to students.

NOVA: Acknowledgment of Assurances – Phase 1 Report Plan + 2022-2023 Funding and Requirements (2022-2023):

A presentation was made to MPC regarding the one-time funding in support of continuing Guided Pathways. SDCCD received \$1,381,160 of the \$47,500,000 distributed amongst all California community colleges. Mesa's portion of the \$1,381,160 is \$542,098. There are three phases of funding. For Phase 1, each college is required to agree with the program requirements that were outlined by the Chancellor's Office (Acknowledgement of Assurance) with emphasis on projects such as: SEA Program, Associate Degrees for Transfer (ADTs), Zero Textbook cost (ZTC) Programs, Adult Education, and Strong Workforce. Mesa College has submitted its Acknowledgement of Assurances. Phase II will be out in later this Fall and will consist of workplan for our Mesa Pathways work for the years 2022- 2024. The CCCO is still developing the work plan content and structure. Phase III will be out in June 2023; the Chancellor's Office will make a determination based on the Phase II required work plans. Student Success Teams:

The Student Success Team project team core members are actively engaging with students and meeting with great success. Students are being informed about activities on campus as well as supports that are available through the college. Students are contacted every two weeks.

Students were directed to the Career Compass, were introduced to the Pathways Fellows who are on the Student Success Teams. The Pathways Fellows developed an activity that will remind students to enroll in the 2nd eight-week class for a transfer level math/English.

This project team will continue to meet throughout the semester to monitor and/or modify their communication and intervention plan, and will be providing updates to MPC throughout the semester. Special thanks to the project team leads: Ian Duckles, Gina Abbiate and Pahua Vang, as well as the pilot team, for their efforts to successfully launch this pilot.

Data Coaches:

The Data Coaches training program has launched with nine participants. Every other week there will be an inperson meeting with a presentation and then the following meeting with asynchronous materials to access through Canvas. The goal is to prepare the teams to go across campus and have them assist with different projects such as growing into a larger group of coaches, how to utilize their skills across campus, and there will be ongoing trainings as needed. Maybe in the future have a survey on how data is being utilized across campus and measure the efficiency of the program.

People wanted more autonomy for districts and colleges to craft policies that best served their students. The new State Chancellor should have the political skills to prevent the state government from legislating mandates that reduce district/colleges autonomy. Attendees were especially critical of Guided Pathways and the Student Centered Funding Formula. The CSU needs to stop how they are currently reviewing courses for Area F, and read the course outlines for these courses and make intelligent determinations, not use a cookie cutter approach."
