Through a competitive process, San Diego Mesa College Foundation will award up to \$3,000 in Innovation Grants to the faculty and classified professionals of Mesa College. These grants will support the development and execution of innovative projects that positively impact student success.

Grants will be awarded in January 2026, with a grant term of one year. Preference will be given to projects that did not receive Innovation Grant funding in 2025, and which support activities beyond professional development. For the 2025 grant cycle, you will be required to submit signed letters of support from the applicable Dean and Vice President. A template for these letters is available on the grant information site. It is recommended that you request these letters of support at least 1 week before the submission deadline.

### **Eligibility**

To be eligible, a proposal must:

- Align with the Foundation's core purpose of supporting the goals and achievements of San Diego Mesa College students;
- Align with at least one of Mesa's 2030 strategic goals: Completion; Scholarship; Community; Pathways and Partnerships; and Stewardship (see: <https://bit.ly/Mesa2030Goals>);
- Address a significant challenge faced by Mesa College students or provide impactful opportunities;
- Be submitted by a faculty member or classified professional of San Diego Mesa College;
- Receive letters of support from appropriate Dean and Vice President;
- Be submitted by the deadline of **Friday, November 7, 2025**.
- Note: The same project is not typically awarded more than one year in a row.

### **Eligible Expenses**

- Supplies for a special project
- Equipment
- Outreach to students or events
- Experiential learning for students

### **Non-eligible Expenses**

- Stipends/salary for staff

## 2026 Innovation Grant Fact Sheet

### Review Process

Proposals are evaluated by a panel of external reviewers from the Foundation board. Decisions are made based on criteria such as meeting Mesa's 2030 strategic goals, impacting student success, and delivering innovation. This is a competitive process, and unfortunately not all proposals will receive funding.

### Grant Term

The grant term runs from January 2026, when award announcements are made, until December 2026. Funds will be disbursed by January 31, 2026. All proposed grant activities, included expenditure of awarded funds, must occur within the grant term.

### Timeline

- ***Grant submission deadline: 11:59 pm on Friday, November 7, 2025***
- Anticipated Award Announcements: January 2026
- Grant Term: January 2026 - December 2026

### Collaboration, Promotion and Reporting

Grantees are encouraged to collaborate with the San Diego Mesa College Foundation via opportunities to volunteer or receive recognition for support. Additionally, grantees are required to sign an agreement and make a short written or visual report/summary about the impact of the grant after the project is completed. Recipients may be asked to make a presentation to the Foundation Board of Directors.

Any applications received via email will not be considered.

Please prepare your application using the Application Template document, as the Application Portal will not allow you to save your responses. You must attach a letter of support from the relevant Dean **and** the relevant Vice President. Applications without letters of support will not be considered. A template for those letters is available to download here:
